**Urgent Field Safety Notice - Urgent Medical Device Recall**  
**Emerge™ Monorail™, NC Emerge™ Monorail PTCA Dilation Catheters**  
**Guidezilla™ II Guide Extension Catheter**  
**Agent™ Paclitaxel Coated PTCA Balloon Catheters**

Dear «Users\_Name»,

Boston Scientific is initiating a voluntary removal of certain dilation and extension catheters. Specific batches of these catheters may have missed the hydrophilic coating step, which creates a lubricious surface on the devices, during the manufacturing process.

Use of an impacted device could lead to increased frictional forces during device deliverability and withdrawal resulting in a procedural delay to exchange the affected device. Additionally, the potential for vessel trauma exists, however there have been no reports of patient injury associated with missing hydrophilic coating. There is no additional follow up needed for patients who have already been treated with affected devices as those in scope of this action are not implanted.

Our records indicate that your facility received some of the concerned product.

Please note that **only the devices listed below are affected. No other Boston Scientific product is involved in this Field Safety Notice.**

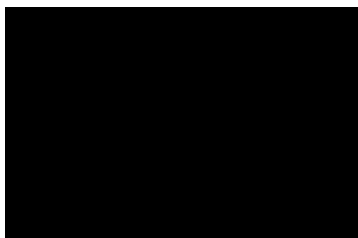
